Corporate officer, Dr. Michael Tirgan, a licensed physician in state of New York, has already developed and submitted 5 research protocols to his local Institutional Research Board.

Corporation will collaborate and work with local and national hospitals to conduct its research. Corporation will solicit and review research ideas and proposals from scientists and fund reasonable research ideas. Corporation is being formed to provide a legal framework so its members and its research program. All fund raising will be done under the auspices of the corporation. All salaries and expenses will be paid from the corporate bank account. This corporation, by way of conducting scientific research will benefit patients who suffer from keloid disorder. Corporation intends to find new treatments for this disease by way of doing research. Except as authorized by Title VIII of the Education Law or other applicable statue nothing herein shall authorize the corporation to engage in the practice of any profession in New York, engage in the training of any profession in New York or use a professional title or term of any profession in New York in violation of Title VIII of the Education Law.
